

Conditions and rules for the registration and use of the portal slovakcentre.co.uk

1. Operator:

The operator of the portal slovakcentre.co.uk is the company HM Promotion s.r.o, Rakytovská cesta 32, Banská Bystrica, Reg. No.: 44 123 981, entered in the Commercial Register of the District Court B. Bystrica, Section: Sro, file No. 15048/S.

2. Registration and personal data:

The registration of the user on the portal is not obligatory, but should the user decide to register, he/she must provide information that corresponds to reality. In case of the detection of erroneous data, the portal operator reserves the right to immediately cancel the user profile.

By registering, the user confirms that the obligatory personal data provided by him/her within the scope of email address are correct and true, and gives his/her consent in accordance with Art. 4 (1)(i) of the Act No. 428/2002 Coll. on the Protection of Personal Data for the processing of his/her personal data by the portal operator. By registering, the user also gives consent to the inclusion of his/her personal data in the database of the operator as well as to be sent information about offers of the operator and its partners.

Provision of personal data, with the exception of obligatory data, is voluntary.

The user also gives consent to the processing of his/her personal data for an indefinite period and may at any time withdraw this consent in writing at the e-mail address of the operator: info@slovakcentre.co.uk.

The operator undertakes not to disclose the personal data of the user (e-mail address) to a third party without the express consent of the user.

The e-mail address notified by the user upon registration serves for the identification, sending of the registration link or new password, sending of offers from the operator and its partners and regular mailing purposes.

The operator is not responsible for any consequences or damage caused by forgotten login data by the user or the abuse of these login data by a third party.

The operator also undertakes to not provide the login data of individual users to third parties.

3. User profile:

The portal operator is not responsible for data provided by users.

The operator reserves the right to intervene in the content of a user's profile.

The portal operator declares that upon the request of the subscriber, it is able to change the data contained in the subscriber's profile. Requests for changes should be sent to the e-mail address of the operator: info@slovakcentre.co.uk.

Each user is allowed to create one profile only. Otherwise, the operator has a right to delete the user's profiles without prior notice.

If the user is inactive for 6 months from the last login, the portal operator reserves the right to delete the user's profile, including all the provided data, photos, contributions to the discussion and reports from the portal.

4. Discussion and evaluations:

A registered user may contribute to the discussion and evaluate products and transactions.

The activities that are referred to above are voluntary and without a claim for a fee. The users hereby undertake that their messages and comments will not be vulgar, defamatory, incendiary, obscene, indirectly or directly propagating violence, racism, fascism or other movements and ideologies leading to the suppression of the rights and freedoms of citizens, and that they will not have a commercial character and will not instigate criminal activity or be in violation of the laws of the SR or other countries.

The operator of this portal is not responsible for the content of the messages posted on the portal by users, or for the content of the contributions to the discussion, and it is not responsible for any violation of intellectual property rights or other rights by users.

The operator also reserves the right to intervene in the user profile as well as the right to remove comments, if they violate these rules, good morals or the laws of the SR or other countries.

Note: The operator has a right to the selection of users. The operator also reserves the right to cancel the user profile without any indication of a reason.

5. Cancellation of profile:

The operator reserves the right to cancel the user profile in the following cases:

- Data provided upon the registration of the user are erroneous
- The user has more than one profile
- The user was not active for 6 months from the last login
- In spite of the reminder from the operator, the user did not refrain from the posting of photos and comments that are contrary to the portal rules – in case the cancellation of the user profile will be final and the user will not be allowed to create a new profile.

The user has the right to apply for the cancellation of the user profile by sending a mail to the address info@slovakcentre.co.uk.

6. General:

Dissemination of any data located on the portal is only possible with the prior written approval of the operator.

The operator reserves the right at any time to amend the specified conditions and rules of the portal, in which the users undertake to further observe these conditions and rules. Should the user disagree with the new conditions and rules he/she must cease using the portal.

The operator reserves the right at any time to close the portal, including without giving a prior notice to the users.

The operator is not responsible for the data stored on the portal in case of any attack against the server.

The operator is also not responsible for any consequences that users may experience from the use of this portal.

By registering, the user manifests his/her consent to the portal rules as referred to above and undertakes to fully abide by them.
