Anglo-Hormani a Stepdowk: 1066 - 1347

V roku 1066 vojveda Villam z Mormandie napadol Britániu a slávne porazili anglického kráľa Harolda, ktorý bol podľa legendy zasialnutý šlpom do oka v bále u Hastingau. Villam z Normandie potom vládol Anglicku a Stálka u aduklalne zmentlitendy systémi. Urdadým jazvýcho bola zavodené abecúztíčna. V roku 1216 bol Jindrich III. korunovaný za kráľa, ale nikdy sa nestal obřůbeným panorníkom.

Tudoroci a Stuatorci 1485 – 1713

V solu 1485 vnikel Herinich Tudor do Anglicka a porazil Richarda III., aby ziskal absolutru moc.

Po úspránom Vlazatre si Herinich Tudor czal Alžbértu z Yorku (kloru Edwarda IV.) za svoju právoplatnú mandallu. V niku 1603 Alžbérta I. (panienská kráľoma) zomneta boz teho aby po sobe zanechala rakstropu za trón. Jakob IV. Skóžsky kráľ (nyh Márie, škóžsky kráľ (nyh) nastúpi na trón ako Jakub II. kráľ Anglicka a tylmó sa stál prým kráľom Spejnelho Kráľousta.

Stuatovi: 1714 - 1835
Po sunti kráľovnej Anny sa stal kráľom Juraj I. Počas jeho vlády vznikla funkcia predsedu vlády. Aj kod
sa v tejlo dobe temin *predseda vlády* ešte nepoužívať. Se Robert Walpole obsadí túto funkciu vdaka
svojim zásluhám za ekonomický raznej krajiny.

Začiatok 20. storočia - 1901 - 1944

V poromani s predošlým odobím zaznamenala Británia začiatko 20. storočia nebývalý pokroli vo vede a technologi. Medzi priekopické úspechy tejlo doby potri ynaliez teleuzíra firmos EMI-Marconi, nasleduje zazločenie fizicka Vyvislacez goločnosti (BEO, objec presicilia). Alexadom Fiermigom a poznatky, ktoré viedly k objasneniu štruktúry atómu a k vývoju nukleámych zbraní a energia.

Obdobe po il svetovej vojne 1945 - 2005

V roku: 1945 robotničica sirana (The Labour Party) zaznamenala svoje prie vitazatio v celoštátných vlobách, po ktorých zaneda štátnu zrimenimi stanoslivost, čo je považovana za napačiží úspech tejo strany. Povoporu pridelový systám bol dalej vydahany, ale aj tak sa celé toto obdobe vyznačovana antuziazmom fludu a novou nádejnu do budúcnosti. Od tejo doby češtla Británia niekoľko akonomickým
